Social Media

Nicole Martino volunteered to work on Social Media (Facebook, Instagram, Tik Tok). Tom recommended that something be posted every day. QR code should always be posted with the opportunity to donate.

Fund Raising

Nicole Martino will meet with Mark Dubrey & Tom Donahue to discuss how we might handle fundraising.

Golf Fund Raiser

Forret Edwards has agreed to put together a golf fundraiser. Tom thinks Forrest has chosen Adirondack as the golf course.

Graphic Design

Nicole Martino will discuss with her husband, Mark Newell, graphic design for 1814 Commemoration Inc. Nicole also volunteered to do some research on sources for banners. Tom mentioned that we have been paying Jodi Brunner for graphic design. She may charge \$45. per hour. We need a basic logo that will be recognized as representing 1814 Commemoration Inc. Battle of Plattsburgh.

Graphic design is needed for:

- Posters
- Banners
- Flyers, letters,

Nicole will submit some samples of her husband's graphic designs.

Tom has done our posters for several years.

Leave off dates whenever feasible.

Hospitality

Nicole Martino is willing to work on hospitality and scheduling.

Sound, Entertainment & The Strand

Russell Feher will continue to work on sound for us. He also volunteered to Chair the Entertainment Committee. He will meet with Jerrod, the Director of The Strand, to discuss our collaboration. Jerrod expressed interest in helping us with a fundraising event. Tom will send Jerrod an email to say that Russell will be working with him and that we are interested in working together on a fundraising event for 1814 BOP.

Grant Writing

Wendy Gilchrist is interested in learning to write grants. Tom will email all the Board information on free grant "training."

Mailing Database

Judy Lefebvre will create a mailing list of donors who gave in the past. In other words, separate out those who never gave. Judy suggested that we consider what composing the mailing. In 2023 there were a number of full color enclosures. We might consider an email to those who never donated. Pennysaver gave us a great price for mailings in 2023.

Magazine

There was discussion on the magazine with lots of ideas put on the table. Currently the magazine is about 70 pages and costs about \$6,000. Without ads, the number of pages might be 40.

Possible printers include:

- Studley
- Northeast Printing
- Border Press

Turnaround to print the magazine is about 2 weeks.

If we want to have the magazine ready to "sell" with the buttons (May 15) we would need everything completed by May 1 at the latest.

Alternative ideas:

Smaller magazine with some of the features we like, for instance articles that can be put together now. A "generic" schedule could be included. Closer to the event, the "final" schedule can be printed and made available at the Information Booth.

We began selling buttons in May in 2023.

Tom contacted the Lake Champlain Maritime Museum to try to engage them in the Battle of Plattsburgh Commemoration. He asked if they might like to participate in the weekend, perhaps provide a boat? He mentioned that we might want to use as a theme for the 2024

Commemoration – Boats on Lake Champlain? Tom mentioned that he will contact Ethan Allen Homestead to encourage their participation. How about 1814 Homestead?

Billy Jones

Tom is following up on money Billy Jones said we should have received (\$25,000).

<u>Meetings</u>

Tom suggested that the Board meet <u>separately</u> before the Committee meetings, maybe an hour before. He said that according to our bylaws, the Board only needs to meet 4 times per year but for now we should schedule monthly meetings. They can be canceled if they are not needed. Chris said that right now it appears that Tuesdays around 5:30pm seem reasonable for our current board members. Exception: Russell cannot meet on Tuesdays from July through August. 3rd Thursdays are not good for Russell.
